Advertisements will be billed quarterly. Advertisers may arrange to have charges billed to credit cards.

Payment is due within 30 days. A monthly finance charge of 1.5% will be charged on all past-due balances.

Unless otherwise stated, ads will run quarterly until canceled. If an advertiser fails to submit new artwork or fails to proof new artwork before the issue deadline, the WINDBLOWN WITNESS will rerun the ad from the previous issue.
